

## Terms and Conditions for MICE BD 2024 Hosted buyers

Those, who are interested in participation as a hosted buyer at MICE Business Day 2024 must complete and submit the [application form](#) by 15 July 2024.

All required sections of the application form must be fully completed.

Completion of the online application form does not automatically guarantee a place on the hosted buyer programme. To be accepted as Hosted buyer, applicant should meet strict qualifying criteria.

After reviewing the application forms, organisers will notify applicants about their participation status. In case of positive confirmation, the hosted buyer registration is completed by paying the registration fee of 80 euros by bank transfer.

PR IN HUNGARY sends the prepayment invoice to the Contracting party, after the transfer.

**The Hosted buyer participation covers:** travel arrangements, transfer, 2 or 3 nights accommodation in 4-5\* hostels, entry to MICE Business Day & related social events, 1 day study farm trip in Budapest, refreshments and lunch during the programmes, personal itinerary of appointments, networking opportunities.

Participation at the pre and post tour is not included in the hosted buyer registration, these can be booked in advance on a favourable price.

All other costs and incidental expenses are the responsibility of each attendee, such as extension of stay, flight upgrades, travel insurance, etc.

**As a condition of receiving the complimentary services, Hosted Buyers will be required to attend minimum 8 Pre-Scheduled Appointments (PSA) of attendance at the MICE Business Day.**

**Cancellation of attendance:** Hosted Buyers may cancel their attendance to the event with no penalty on or before 22 September 2024. Cancellations received after 23 September 2024 will incur a fee of €500 as a cancellation fee.

All cancellations must be received by Turizmus Ltd in writing by the dates specified above and acknowledged by Turizmus Ltd. Hosted Buyer who has to cancel participation due to medical reasons must provide a medical certificate within one week.

**No Show:** Hosted Buyers who do not inform the Turizmus Ltd. of their cancellation and do not attend Show will incur a no show fee of €800.

**No show to Appointments:** All Hosted Buyers are required to attend all Pre-Scheduled appointments that appear in their final diary as any no show will negatively affect the Exhibitors diary. Hosted Buyers reported as no shows may incur a fee of €50 for each no show to a Pre Scheduled appointment reported. If Exhibitors report over ten no shows to Pre Scheduled appointments from one Hosted Buyer, the Hosted Buyer will incur a fee of €500 and will not be invited to future MICE Business Day events.

**Contact information:** All hosted buyers name and e-mail address will be seen in those exhibitor's diaries, where the hosted buyer made Pre-Scheduled appointment. It happens, the exhibitor will contact the hosted buyer by e-mail before the event.
